3. ADMISSION PROCEDURE

- i) Candidates will be selected for admission based on the percentage of aggregate marks of all the semesters/years of the qualifying degree (Part-III Mani & Allied Subjects)
- ii) Candidates seeking to apply for different programmes should submit Only One Application.(Multiple applications will summarily be rejected)

Mode of Applying:

Candidates can visit the institute's website <u>www.kmkpgskkl.in</u>, fill-in the application online and take a printout. The printout (Hard Copy) of the filled-in application form together with the requisite enclosures can be directly submitted at Dr. Kalaignar M. Karunanidhi Government Institute for Post Graduate Studies & Research by paying ₹500/- (₹250/- for SC/ST (Origin only)/PwD), The application can also be sent by post, along with a Demand Draft, to

so as to reach on or before (will be notified in the Institute's website).

- iii) Online application can be accessed at the Institute Web Site: www.kmkpgskkl.in.
 Before filling the Application Form, read the prospectus carefully.
- iv) Ensure the following in respect of certificates to be enclosed.
 - 4.1. Enclose only self-attested photocopies of the necessary certificates, in support of different claims. Original certificates must be produced only at the time of counseling.
 - 4.2. All the certificates in respect of various claims should have been recently obtained or updated (within one year prior to the date of applying) from the competent authority.
 - 4.3. Community certificates issued by Govt. of Puducherry will only be considered for claiming reservation benefits.
 - 4.4. Sports certificates must be countersigned by the authorities concerned.
 - 4.5. Rural certificates must be signed by the Head of the Institution of Government School/College, Karaikal/Puducherry, where the candidate perused his/her HSc. Course & UG Degree Programme.
 - 4.6. Candidates who have studied in Lycee Francais and opt for PG programmes should produce an eligibility certificate issued from the Pondicherry University, subject to fulfilling other eligibility conditions.

- v) Applications completed in all respects along with all the necessary certificates (as specified in the Application Form) should be submitted at the Office of The Principal,
 Dr. Kalaignar M. Karunanidhi Government Institute for Post Graduate Studies & Research, Karaikal 609 605.
- vi) Applications received after the last date will be superscribed as Late Application and such applications will be considered only after all the applications submitted on time for the respective programme/category have been exhausted. Defective and incomplete applications will be summarily rejected. No further correspondence will be entertained in this regard.
- vii) Upon receiving the applications, each applicant will be assigned with a unique registration number, which shall be quoted in all their subsequent correspondences regarding admission. Enquiries will not be attended to, unless the registration number is quoted.
- viii) Within 15 days after the **last date** for the submission of applications, a comprehensive list of the candidates who have applied for admission will be displayed on the **Notice Board/Institute's Website** giving the following particulars: Registration Number, Name, Category, Percentage of marks and programme applied for. Candidates can check for the correctness of the particula₹
- ix) Candidates will be selected for admission strictly in accordance with the selection criteria specified in the prospectus and the final list will be displayed on the Notice Board / Institute's Website.
- x) The final merit list, will be posted on Institute Website for all the eligible candidates.
- xi) A candidate eligible for any reservation is also eligible for admission under open merit or resident merit, as the case maybe.
- xii) If a candidate is absent for Counseling for a particular programme, his/her name will be removed from the list of candidates for that particular programme.

- xiii) Options once exercised with regard to Community / Rural /Urban / Special Category is final and cannot be changed under any circumstances.
- xiv) Check List (attached with application must be marked carefully).
- xv) Candidates are required to attend the Counseling at their own cost along with their Parents or Legal Guardians. The Office of the Principal will inform the date and time of the Counseling to candidates. Candidates, if provisionally selected at the Counseling, should pay the prescribed fees immediately. KMKGIPGS&R will not be responsible for any communication unnoticed by the candidate regarding Counseling. For SC/ST Candidates G.O.Ms.No.08/ Wel (SCW) 2020-21/3808, dated 04/01/2021 will apply for remittance of Fees.
- **xvi**) If there are vacant seats after the first Counseling, a second list will be prepared after removing the names of candidates who were absent for the first Counseling. The second list candidates will be intimated to appear for counselling.

7. NATIONALITY CRITERIA

For the purpose of admission to all the PG programmes, a candidate seeking admission should be an Indian National. However, French Nationals residing in the U.T. of Puducherry and covered by the terms of the Treaty of Cession shall be treated on par with Indian Nationals.

8. RESIDENCE CRITERIA

a) RESIDENTS OF THE U.T. OF PUDUCHERRY

An applicant is considered to be a resident of Puducherry if he/she is an **Indian National** and satisfies at least one of the following criteria:

i. The candidate or whose parent (either Mother or Father or Both) or Guardian (in case of children who have lost both the parents) has been residing continuously in the Union Territory of Puducherry for at least five years preceding the last date for submission of application.

(OR)

ii. Those candidates who have passed SSLC/HSC/UG or any other public examination and for that purpose had undergone academic studies continuously for 5 successive years immediately preceding the qualifying examination (including the year of qualifying examination) in a recognized educational institution located in the U.T. of Puducherry and having their residence in the U.T. of Puducherry for 5 years continuously during that period. Mere stay in places such as residential hostels would not amount to residence.

(OR)

iii.Children of natives of the U.T. of Puducherry, who have declared any place in the U.T. of Puducherry as their hometown and so certified by their respective Heads of Office, Nativity Certificate in the prescribed format has to be enclosed (G.O. Ms. No. 64 dated 25th May 2006).

(OR)

iv.Children whose parents are Central/ State Government Servants/ Defense Personnel/ Central Paramilitary Forces/ Employees of Public Sector Undertakings wholly or substantially owned either by the Central Government or by the Puducherry Administration posted and have been serving in the U.T. of Puducherry for at least a minimum continuous period of three years immediately prior to the last date for submission of application.

b) Children of the above-mentioned employees should have studied HSC / S.S.L.C./UG for two years in any of the schools in the U.T. of Puducherry and should have passed the qualifying examinations (HSC/ S.S.L.C./UG) from the same school (G.O. Ms. No. 04, Puducherry dated 09.02.2016 of the Chief Secretariat (Hr. & Tech. Edn.), Puducherry.

(OR)

a. **Children of Defense Personnel** killed or disabled in harness and children of Central Government Servants/ Puducherry U.T. Government Servants/ Defense Personnel/ Employees of Public Sector Undertakings wholly or substantially run either by the Central Government or by the Puducherry Administration who died while in service in the U.T. of Puducherry.

(OR)

b. French nationals residing in the U.T. of Puducherry and covered by the terms of the "Treaty of Cession" shall be treated on a par with the candidates who produce the prescribed Puducherry U.T. Residence Certificate. Such French nationals will not be required to produce Residence Certificate; instead, they should produce a "Certificate of Registration" issued for this purpose by the French Consulate at Puducherry. However, Children of these French nationals shall not be considered for admission under the Non-Resident quota.

c. OTHER STATES

"Other States" refers to seats to students who are Indian Nationals and not Residents of the Union Territory of Puducherry.

9. RESERVATION OF SEATS

Reservations for admission to various postgraduate programmes for candidates from the Union Territory of Puducherry are provided according to the norms prescribed by the Government of Puducherry. The vertical and horizontal distribution of seats by category is outlined below. Community certificates issued by the Government of Puducherry only will be considered for claiming reservation under SC/ST/BT/EBC/MBC/BCM/OBC. Candidates eligible under these reservations are also eligible for admission under the Unreserved (UR) Category in addition to their reserved quota.

Horizontal Reservation (For Puducherry Residents only):

Horizontal Reservation (FF/PwD/ESM/MSP/Rural) will be done if adequate number of seats in horizontal reservation are not filled after fixing vertical reservation i.e., if the requisite number of seats are not filled while doing vertical reservation, then the last candidate in the respective category will be replaced as per merit.

Unreserved (UR):

The seats under Unreserved are open to all candidates irrespective of their caste or category status. Further, all SC / ST / BT / EBC / MBC / BCM / OBC candidates are also eligible for selection under the unreserved category in addition to the reservations due to them.

Other Backward Classes (OBC), Most Backward Classes (MBC), Extreme Backward Classes (EBC), Backward Classes Muslims (BCM) and Backward Tribes (BT):

Candidates claiming admission under these categories should enclose OBC / MBC / EBC / BCM / BT certificate issued by an Officer of the Department of Revenue and Disaster Management, Government of Puducherry, not below the rank of Deputy Tahsildar.

Scheduled Castes (SC):

Candidates claiming admission under this category should belong to a caste which is recognized as a Scheduled Caste under "the <u>Constitution (Puducherry) Scheduled Castes Order 1964</u>" dated 05.03.1964, read with "<u>the Constitution (Scheduled Caste) orders (Second Amendment) Act 2002"</u> (Central Act 61 of 2002) and should enclose the required certificate issued by an Officer of the Department of Revenue & Disaster Management, Government of Puducherry, not below the rank of Deputy Tahsildar.

Scheduled Tribe (ST):

Candidates claiming admission under this category should belong to a caste which is recognized as a Scheduled Tribe under "the Constitution (Puducherry) Scheduled Tribes Order, 2016" dated 22.12.2016 and should enclose the required certificate issued by an Officer of the Department of Revenue & Disaster Management, Government of Puducherry, not below the rank of Deputy Tahsildar.

Freedom Fighter (FF):

Candidates claiming admission under this category should be Children / Grand Children of Freedom Fighters and they should enclose the necessary certificate issued by the Officer-in-Charge, Freedom Fighters' Cell, Government of Puducherry, Puducherry.

Person with Disabilities (PwD):

Candidates seeking admission under this category should be residents of the Union Territory of Puducherry suffering from not less than 40 per cent of any disability as certified by a competent Medical Authority, Government of Puducherry. They should also produce a full-size photograph exhibiting deformity.

Wards of Ex-servicemen (ESM):

Those who are registered as Ex-servicemen in the Department of Sainik Welfare (DSW), Government of Puducherry and have got an Ex-serviceman / Widow of Ex-serviceman identity card from DSW should enclose the necessary certificate issued by the Director, DSW, Puducherry.

Meritorious Sports Person (MSP):

- i. The highest achievement of the candidates in only one annual tournament under the listed sports disciplines in a year will be considered for awarding marks.
- ii. The list of Sports Disciplines eligible for seats under sports quota is given in **Annexure II.**

Selection of candidates under this category will be based on the marks obtained by the candidates following the guidelines given by the Government of Puducherry vide G.O. Ms.53 dated 24 th May 2012 and G.O. Ms. No 6 dated 14th March, 2018 of Chief Secretariat (Higher & Technical Education), Government of Puducherry.

- iii. Participation / Achievements in sports / games shown in the above list in the five years immediately preceding the year for which admission is sought only will be considered. National / State Level Championships / Tournaments conducted by Organizations / Federations recognized by Indian Olympic Association / Ministry of Youth Affairs and Sports, New Delhi only will be considered for award of marks (Recognition by the Indian Olympic Association / Ministry of Youth and Sports, New Delhi should be relevant to the period of years concerned).
- iv. Open /Invitational Tournaments of any kind will not be considered.
- v. For Tennis, Achievements of Top 3 players by his/her position in the ranking list published by AITA based on the ranking rules and the final rankings of the previous 4 years will be awarded marks for achievements and participation (Necessary credentials from such Associations are to be enclosed).

- vi. For Cricket, the Annual Official Championship / Tournaments conducted within the country under the auspices of BCCI at District / State National Level only will be taken into consideration for that year.
- vii. The participation / achievements of candidates with nativity of Puducherry Union Territory and who represented the Union Territory of Puducherry only are eligible for marks under National Category.
- viii. Candidates are eligible to apply for admission under Sports Quota even if they have studied in KVS/NVS/CBSE Schools within Puducherry.
- ix. All the achievement certificates are to be supported necessarily by the relevant participation Certificates and appropriate forms /certificates.
- x. No further enclosures of certificates will be entertained after the last date for submission of completed applications.
- xi. A candidate can utilize the sports quota only once for these admissions.
- xii. The relevant attested copies of the certificates issued by the appropriate authorities as detailed in the G.O Ms. No. 53 dt. 24.05.2012 are to be submitted along with the application.
- xiii. A Committee will be constituted to scrutinize the applications received under this category and it will rank the candidates based on the marks assigned to the certificate/s enclosed along with the application and the sports merit list will be published in the Institute's website/Notice Board.

Note: The list of eligible sports Disciplines for seat under Sports Quota will be as per G.O. (latest if any) issued by the Government of Puducherry from time to time.

Students from Rural Schools and Colleges

Applicants seeking admission under the rural category must have completed five years of continuous study immediately preceding, and including, the year of qualifying examination in a Rural Government School and Government Colleges located within the jurisdiction of the respective Commune Panchayats listed by the Government of Puducherry for this purpose (Refer **Annexure III**). The certificates for rural category must be endorsed by the Head of the Institution of the Government School and College in Puducherry.

Note:Candidates seeking admission under this category should submit the prescribed application with all relevant documents about Residence, Nativity, and Community (original certificates are not required at this stage). It is sufficient for candidates to declare in the application that all the information provided is correct, acknowledging that false information will result in cancellation of their candidature. Candidates must present their original certificates supporting their Residence, Nativity, Community, etc. at the time of admission.

10. ELIGIBILITY CRITERIA:

For admission to any PG Programme, a candidate shall fulfill the necessary eligibility requirements for the respective PG Programme, as prescribed by the Pondicherry University. The details are as follows:

11. SELECTION PROCEDURE

11.1. Procedure for Determining the Merit Score:

Candidates will be selected for admission based on the percentage of aggregate marks of **Part III Main and Allied subjects** in all semesters/years of the qualifying UG degree programme.

11.2 Order of Priority for Tie Break

In the event of a tie, the following steps are to be adopted.

- I. Total marks of all semesters/ years are to be compared (including all Part subjects).
- II. In case the total marks result in a tie, it will be resolved using Date of Birth. A candidate of higher age will be ranked higher.

11.3. Merit List:

The merit list is prepared by combining 11.1 & 11.2.

12. ADMISSION PROCESS

- a) The Candidates will be called for admission as per the order of merit.
- b) The admission will not be done in the absence of a candidate.
- c) Candidates called for admission must submit all the ORIGINAL certificates for verification. Extension of time will not be given to produce them on a later date.
- d) Candidates are advised to take adequate number of photocopies (xerox) of the original certificates before submitting for verification during the admission process.

15. OTHER INFORMATIONS

The postgraduate programmes at this Institute adhere to the Semester system. Each academic year comprises two semesters, each lasting 15-16 weeks. The Institute operates from Monday to Friday. The faculty members are highly qualified in their respective disciplines. The academic programmes encompass a wide range of activities including formal lectures, tutorials, integrated MOOCs, group discussions, library, research projects, assignments, seminars, workshops, internships, viva-voce, and other modern teaching methods.

a) Minimum Attendance

Students should attend all classes regularly and punctually. Students must secure a minimum of 75% of the attendance in each semester to be eligible for the End-Semester Examinations. Failure to meet this attendance requirement may result in disqualification from appearing for the University Exams.

b) Discipline

The Institute aims to uphold a high standard of discipline among its students. Students are expected to comply with any general or special rules set by the Institute from time to time and must provide written declaration in the prescribed form. This form should be signed by both students and parents/guardians in the presence of the Director of the Institute.

Students are advised not to affiliate themselves with any political party or organization within or outside the institute campus.

- The use of alcohol and intoxicating drugs within Institute premises is prohibited.
- Students should refrain from participating in agitations and demonstrations.
- Students should carry their Identity Card issued by the Institute at all times.
- Any act of disobedience or misconduct by a student will be reported to their respective parent/guardian and will be viewed seriously, potentially leading to suspension, dismiss, or other actions depending on the severity of the misconduct.
- The Principal of the Institute reserves the right to issue a Transfer Certificate to any student at any point of time during their programme due to indiscipline, non-payment of fees/dues on time, or continuous absence from class for more than 10 days, requiring the student to leave the Institute.

c) Anti-ragging

As per the notification issued by the Ministry of Education, Government of India, New Delhi (letter No. 9-18/2008 [U-5] dated 29th April 2008), ragging is prohibited and carries severe penalties, including imprisonment for up to two yea₹ Any student found participating in any form of ragging will be immediately expelled from the Institute. At the time of admission, candidates and their parents are required to sign an undertaking to acknowledge this condition.

d) Medical Examination of Students

Candidates who are provisionally selected for admission to the Institute are required to undergo a medical examination by the Students Health Officer and provide the original Cumulative Health Record at the time of admission.

e) Students' Co-operative Stores

All students are required to enroll as members of the Students' Co-operative Stores.

f) Scheme of "Grant of Full Fees"

According to G.O. Ms.No.8/Wel (SCW)/2020-21/3808 dated 04.01.2021 by the Government of Puducherry, the Adi Dravidar Welfare and Scheduled Tribes Welfare Department implements the "Grant of Full Fees" scheme. This scheme provides full fees for eligible SC/ST (Origin) students, without considering income limits, for Higher/Professional courses ranging from 1st Standard to Research Studies. The scheme is applicable to two children per parent.

This scheme provides eligible SC/ST (Origin) students with coverage for tuition fees, including examination fees, lab fees, book fees, uniform fees, and other non-refundable fees.

Therefore, the eligible SC/ST (Origin) students are exempted from paying the tuition fee at the time of admission.

Final Authority to settle any dispute in the matter of admission will be The Director, Directorate of Higher and Technical Education (DHTE), Puducherry or any Authority appointed for this purpose.


